THE DIFFERENCE BETWEEN STANDARD DOCUMENTS AND PREMIUM SERVICE

To make an existing automatically reversionary pension non-reversionary, or to otherwise remove a nominated reversionary beneficiary, the governing rules and pension documents must empower the trustee of the fund to change the reversionary nature of the pension. Accordingly, it is vital that:

- the governing rules be identified;
- all documentation is reviewed to ensure that it has been correctly drafted and correctly executed;
 and
- any deficiencies be appropriately dealt with.

As part of our premium service we perform the above tasks to provide feedback on any further work that may be needed.
