Default Condition: A current member or members, who hold greater than half of the market value of all member accounts in the Fund can either individually or collectively give the Member notice that they want the member to exit the Fund.		

If the conditional member has been provided full knowledge of the basis of their admission and the ability for them to be removed from the Fund, then the documents have a firm legal basis of withstanding legal challenge. However, the documents may still be subject to scrutiny by a court which may take a different view especially in a contested family law dispute.

Note that any member that is employed by another member or related entity must be a director of the employer-sponsor or a relative of such a director. Also, persons previously convicted of an offence involving dishonesty or who are bankrupt are disqualified from being admitted to an SMSF. Further, all members must generally be trustees or directors of the trustee company and all trustees or directors of the trustee company must be members of the Fund. Please note that the trustee structure must be amended before admitting a new member (s 17A(5) of the *Superannuation Industry (Supervision) Act 1993* (Cth)). Expert advice should be obtained if in doubt as severe penalties can be imposed for breach of the member/trustee rules. Please also complete a change of trustee order form if the trustees are individuals.
